Inclement Weather is always a possibility in North Florida. Pony Rides Event Rules for Safety

The following Rules for Safety are provided to help ensure your event is very fun and enjoyable, but also provides a safe atmosphere for the ponies.

1. Please watch your children at all times. There can be no hitting or being mean to the ponies.
2. Running around or behind the ponies is strictly prohibited.
3. Keep hands from around the mouth and there should be no food or drink around the ponies.
4. No balloons or bags around the pony as sudden noises could startle the ponies.
5. Parents are welcome to walk next to the ponies while there children are riding.
6. Our ponies will be led by an experienced handler. At no time will the ponies be unattended. Please follow the handler's instructions carefully.
7. Weight limits for Pony Rides is 150 lbs.
8. Shoes must be worn around the pony at all times. Sandals are not recommended.
9. We are licensed and insured. Those documents are available upon request.
10. We recommend any family pets be kept inside during the pony rides as they may not be used to being around the ponies

Fla. The undersigned agrees for himself or herself, dependents, for persons coming onto the premises with the undersigned's express or implied permission, invitation or knowledge to assume all risk and hazards and agree to fully **INDEMNIFY, DEFEND AND HOLD HARMLESS**, All American Pony Party, and their owners, employees, volunteers, and representatives from:

(1) any and all claims, demands, liability, injuries, death, property damage or loss or other remedies or damages arising out of or resulting from the **INHERENT RISKS** of participating in or observing horse related activities including but not limited to, the risk of horses kicking, biting, spooking, tripping and falling.
